These papers were received from an antique dealer in Meridian Mississippi who acquired them in an estate sale. They were of no use to her but she felt she should not destroy them. The day after she received them I came in, mentioned I was from Texas and worked on genealogy and she said "They're yours. You were meant to have them". She had no explanation of how they ended up in Mississippi. They are burial permits for the State Cemetery in Austin, Texas for the years 1933, 1934, 1935, 1936, 1937. Most of the permits are for very elderly persons, probably from some kind of hospital or nursing home. ~Shelley Sonleitner, October 6, 1988.

Shelley Sonleitner's theory was absolutely correct. Most of the burials are for men who were in the Texas Confederate Home or the women who were inmates in the Confederate Woman's Home in Austin, Texas and subsequently buried in the Texas State Cemetery, 909 Navasota Street, Austin, Texas 78702 Tel 512.463.0605 Fax 512.463.881.
