That the China Grove Cemetery, located in RESERVE "A", CHINA GROVE VILLAGE, SECTION ONE, CHINA GROVE SUBDIVISION, Montgomery County and previously filed and recorded in the Official Public Records of Montgomery County, Texas, in Vol. 45, Pgs. 170-171; Vol. 457, Pgs. 388-392; Document No. 718-10-2886; and more particularly described in *Exhibit A* as attached hereto, has been set aside and dedicated for cemetery purposes through historic use and that such property is now occupied by human graves.

That the Texas Historical Commission has duly considered the evidence of existence and historic use of said cemetery and has listed said cemetery as a Historic Texas Cemetery, worthy of preservation.




