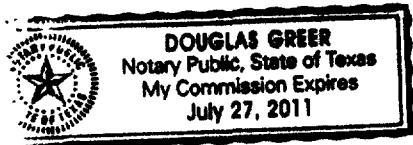
The Family Cemetery shall be used exclusively for cemetery purposes and the filing of the Dedication along with the attached map shall serve as constructive notice of the Dedication.

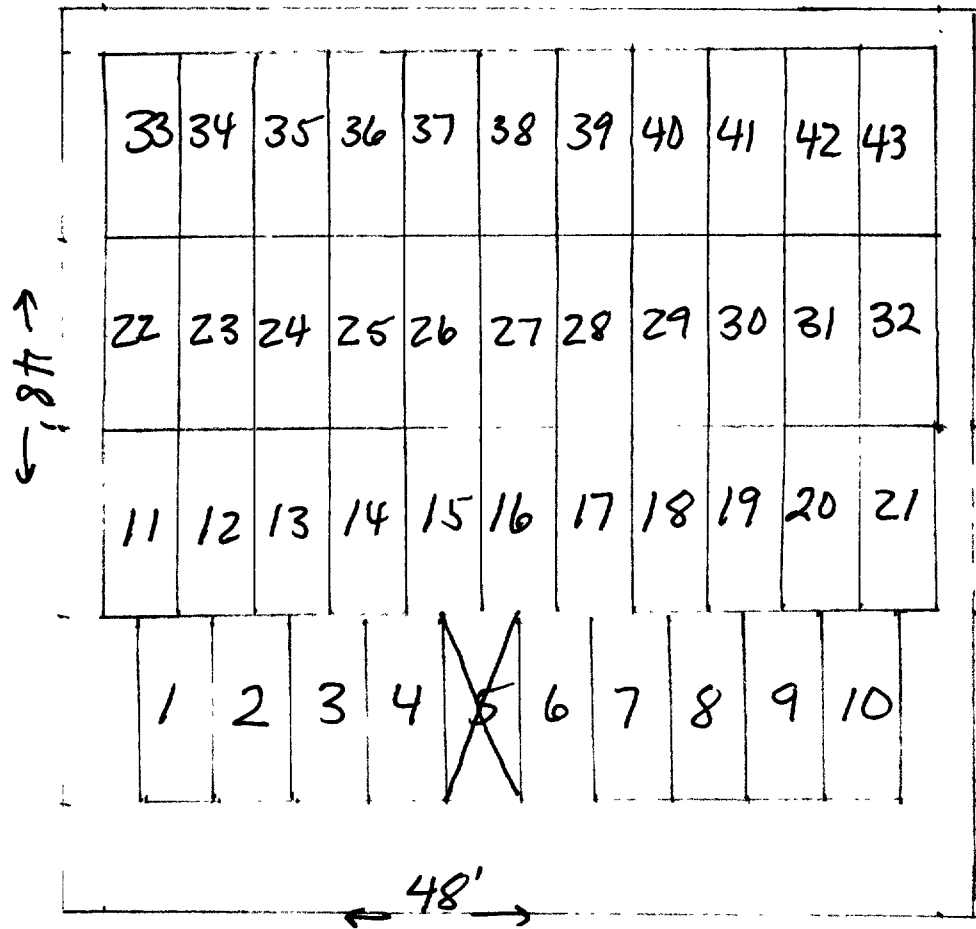
